
All the above promotions are liable for reversion in the following circumstances, if any, may arise in future.

- a) If found not eligible due to pending crime case / disciplinary action or any other reason, on verification by the unit heads concerned or as per direction from the higher authorities.
- b) Orders from the authorities concerned, consequent on the disposal of seniority dispute between police personnel.
- c) If sufficient vacancies are not available, while regularizing the temporary promotions.
- d) If any senior is found excluded from this promotion order, due to omission in the select list.

The promotion ordered will be regularized only after the promotions to the cadres of SI and ASI are ordered or sufficient number of vacancies are arose in the cadre of SCPO.

The probation in respect of the persons promoted will commence from the date of regularization of temporary promotion.

The Units Heads including the Special Units will ensure that the promotions will not be effected in the case of retired /death case/under suspension/ long leave (LWA) et c. They will report such cases to the undersigned for further action.
