Belated quotations will not be entertained. Advance payment will not be allowed.

Firms which would like to participate in the quotation may offer their least price against each items mentioned above, including GST and excluding Flood Cess, for each machines mentioned in the Annexure-1.

The acceptance of the quotations will be subject to the following conditions:

1. The successful contractor will submit month-wise bill within 5th day of the succeeding month for payment and the payment for supplies made or service rendered shall be released subject to the availability of allotted fund.


