Sub : Disciplinary action against Sri.Dinu V.G, GSCPO 6613 (PEN:364928), Mangalapuram PS, Thiruvananthapuram Rural – Oral Enquiry ordered - Orders issued.

As per the reference cited 2nd, it is reported that Sri.Dinu V.G, GSCPO 6613 (PEN:364928), Mangalapuram PS, Thiruvananthapuram Rural had filed a petition before the Vigilance & Anti Corruption Bureau alleging that, his leave application was rejected by District Police Chief, Thiruvananthapuram Rural, citing the reason that a loan repayment is pending. Further it was alleged that Smt.D.Silpa IPS, Superintendent of Police, Thiruvananthapuram Rural District and three others namely Sri.Sajikumar, Administrative Assistant, Smt.Jisha and Sri.Sanju, A9 and F6 section clerks respectively all of them working in Thiruvananthapuram Rural District Police Office have demanded bribe for sanctioning the leave.

The petition was enquired by the Vigilance & Anti Corruption Bureau SIU -I and a report was submitted by concluding that the allegation levelled against the above said officials that they have demanded bribe does not sustain in evidence. Raising unnecessary allegation against responsible officers without any ground is very bad and vide reference cited 2nd, it was recommended to take disciplinary action against Sri.Dinu V.G, GSCPO 6613 .

Sri.Dinu V.G, GSCPO 6613 filed a complaint against his superiors by deliberately making false allegations and the act occurred from his part warrants stringent disciplinary action. In the above circumstances as empowered under Rule 8 (I) (III) of KPDIP and Rules 1958, an **Oral Enquiry** is hereby ordered against Sri.Dinu V.G, GSCPO 6613 (PEN:364928). **The Additional Superintendent of Police, Kollam City** is authorized to conduct the Oral enquiry. The enquiry officer should submit the MOC for approval within 14 days and PR minutes within three months.
